Dear President, Secretary General,

As Chair of the Local Organizing Committee I would like to invite your team to be part of the European Grand Prix 2025, which will be held in Arnhem, The Netherlands, from 21-26 July 2025. Arnhem, the capital city of the province Gelderland, is the 13th city of the Netherlands, with almost 168.000 inhabitants. Besides the beautiful nature around Arnhem, the city has very interesting musea and history, a beautiful zoo and it is also the city where our National Olympic Sport Centre Papendal (TeamNL Centre Papendal) is located and where several sports have their High Performance programs, including archery. In 1980 the 6th Paralympic Games have been organized in Arnhem, with 2500 athletes of 42 nations in 18 different sports.

The tournament will be organized following World Archery and World Archery Europe European Grand Prix and World Ranking Event rules for recurve and compound divisions.

According to EGP rules, each country can maximum register 6 archers per division and category plus individual club entries, in contrast to World Cup events where a maximum of 4 archers per division and category can be registered.

The prize money offered to the winners is not negligible and we hope it will attract the attention of many archers and the best among them.

The participation is open to all World Archery Member Associations and club members.

We are looking forward to your arrival.

PRELIMINARY & FINAL REGISTRATION

All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using the World Archery Online Registration System WAREOS. This system handles the entire registration process for this event. No entry forms, hotel reservations or transportation forms will be accepted!

Member associations can login to WAREOS at <http://extranet.worldarchery.org> with their username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the "Entries" button to see the list of categories in the event. Select/press the "category" to enter the athlete and official numbers/details participating for that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

Club archers can register on Open WAREOS at <http://extranet.worldarchery.sport> with their username and password if already registered in the past, or register to get the log in details if it's the first time. After the creation of the profile, follow the instructions to register to the event.

Contact wareos@archery.sport in the World Archery Office with any questions regarding technical problems on WAREOS. For any question regarding the organization of the event (transport, accommodation, meals etc.) please directly contact the LOC.

A maximum number of 6 men and 6 women per country can be registered into each category and division of the event. The host country may enter the maximum of 8 men and 8 women per division.

EGP Rules (latest version 2024, also valid in 2025) on WAE official web site.

Member associations should only use WAREOS to make any changes/amendments to their entries and will be able to do so at any time. An email will automatically notify the Local Organizing Committee and Member Association of any changes made in WAREOS.

Member Associations that have penalty fees outstanding from earlier events will need to pay these penalty fees by bank transfer and get good standing before being eligible to enter and compete.

Also, World Archery fee must have been paid prior to participation.

Please respect the stated deadlines.

However, any changes that are made after the deadlines specified or if entries differ by more than 4 participants from the preliminary entries, the following penalty fees will automatically be applied:

Penalty fees to be paid to Organizing Committee	Cost
Entries made after the preliminary and/or final entry deadline date.	50 EURO per entry
If final entries differ from the preliminary entries by more than 4 athletes/officials.	150 EURO per entry
Failure to have made preliminary entries before the deadline date but then have submitted final entries	150 EURO per entry

Any entries received less than 3 days before the Team managers meeting will be refused if no preliminary entry and/or final entry are made prior.

Entries and substitutions received after the deadlines are subject to penalties as clearly stated in the rule book and the World Ranking Event invitation documents. A Member Association that has made final entries in WAREOS and does not participate, will be invoiced for the number of entries entered in the system as well as any other booking they made through the platform (including but not limited to accommodation, transportation, and other extra the Member Association has booked through the platform).

Regulations for Club Archers participating

Club Archers (i.e. athletes not competing as country), can register on Open WAREOS with their username and password if already registered in the past, or register to get the log in details if it's the first time. After the creation of the profile, follow the instructions to register to the event.

This doesn't guarantee his/her participation. The process of registration and inclusion must respect the Club Archers' regulations and procedures to be able to participate to this event. Club Archers participating in World Ranking Events must be members of a World Archery Member Association (therefore official members of the Archery Federation of his/her country). The athlete's national federation will be able to veto the entry if required.

Dress regulations: Club archers must respect WA Rules (Book 1, point 3.22) in terms of uniform for the WA events. Club archers cannot use any National team uniform (neither of this country nor any other).

ENTRY FEES

Individual	200 EURO per athlete
Officials	100 EURO per person
Teams	125 EURO per Team (Mixed Team free of charge)

Temporary Upgrade: 30 EURO per accreditation (for athletes - to be a coach temporarily).

Member Associations that have penalty fees outstanding from 2025 will need to have paid these penalty fees before being eligible to enter and compete.

Any entries received after the final registration will be refused. Only substitution will be allowed.

CANCELLATIONS & CHANGES

All cancellations and changes must be made through WAREOS:

- Cancellations received before 20 April 2024 a full refund of the deposit payment will be made.
- Refunds will be processed after the event.
- Cancellations received after 21 April 2024 no refund will be given.
- Name changes to team officials or athletes (same category and division) will be accepted up to 72 hours before the event without any additional charge.
- Should arrival details change last minute, please contact the Organizing Committee using the details indicated in the Team Managers' Booklet.
- If a participant's arrival is later than the original scheduled arrival date, the room charges will start from the dates of the original booking made by the Member Association.

Terms and Conditions

Introduction

The Member Association acknowledges to have understood and accepted in their whole and without any restrictions the sale and purchase terms and conditions of this invitation package, and of the registration platform <https://extranet.worldarchery.org/wareos/>.

Consequently, the Member Association who wishes to register to an event, and book some or all associated extras proposed by the local organizing committee acknowledges that they are fully aware present terms and conditions are accepted by entering information in WAREOS.

Any Member Association declares that it is entitled to enter a contractual relationship with the Local Organising Committee of the event, in accordance with these terms and conditions.

The Local Organising Committee commits itself to communicate, within reason, to its potential clients the greatest information available on the following topics: Description of the main characteristics of the proposed products and of their use.

Pricing

Information on the methods of payment and reimbursement conditions.

Article 1: Entirety

The platform <https://extranet.worldarchery.org/wareos/> is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising

Committee to facilitate registration to World Archery events.

The present terms and conditions include any and all rights and obligations of the parties. No single, specific, or general term or condition that may appear on documentation sent, given, or handed over to a Member Association will alter, replace, or complete parts of or the entirety of these terms and conditions. World Archery reserves the right to modify at any time and without any preliminary notification of any kind these terms and conditions.

Article 2: Object

The present terms and conditions define the rights and obligations of the parties in relation to the registration made through the platform <https://extranet.worldarchery.org/wareos/> of services offered by the Local Organising Committee in the scope of the event it has been set for.

Article 3: Contractual documents

The present terms and conditions and the registration process make up the contractual documents between the parties.

Article 4: Electronic signature:

The Member Association's entering registration information is the electronic signature which is binding between the parties in the same sense as a handwritten signature would be.

Article 5: Registration Confirmation – Contract

The contract is validated as soon as the Member Association has entered its preliminary registration by entering

information in WAREOS. A modification of the registration is possible until the deadline for registration set in the document. Modifications may be subject to penalty fees.

Article 6: Prices

The official prices are listed in the “Policies and Procedures Athletes, officials and team management”, the invitation package prices will be based on the official price list, converted to the currency elected by the LOC for invoicing (CHF, EUR, or USD). The official prices valid on the date that the registration confirmation is sent to the Member Association are binding between the parties.

Article 7: Payment methods

All payments shall be made by bank transfer to the organising committee respecting the stated deadlines, with all bank charges paid by the Member Association. For any open invoices that are not settled 21 days prior the beginning of the event, the Local Organising committee will be entitled to charge a 5% surcharge on all open amounts. Any payments received cash by World Archery on behalf of the organising committee will incur a 10% additional service fee, to be paid to World Archery.

Article 8: Payment deadlines and refunds

After the preliminary's entry deadline, the downpayment of 50% shall not be reimbursable. After the final deadlines of registration mentioned in this document, Member Association will not be entitled to any refund, and all remaining unpaid amounts shall be paid to the Local Organising Committee.

Failure to do so, will result in an immediate suspension of the Member Association, who will be set as not in good standing on the day of the official practice of the event, and so until the full amount is paid to the LOC.

Article 9: Availability of services

The availability of services is guaranteed on a first come, first serve basis, provided that the payment of such service has been paid to the local organising committee, partially or in full as mentioned in this document.

The local organising committee is not required to hold services for a Member Association that has not paid in full for such service.

Article 10: Force-majeure

None of the two parties will have failed in their respective contractual obligations if their execution is delayed or prevented by a case of force-majeure. Cases considered to be a force majeure are extraordinary events or circumstances beyond the control of the parties, such as a war, strike, riot, crime, or an event described by the legal term "act of God" (e.g., flooding, earthquake, volcano eruption, etc). However, force majeure is not intended to excuse negligence or other malfeasance of a party, as where non-performance is caused by the usual and natural consequences of external forces, or where the intervening circumstances are specifically contemplated.

The party experiencing a force majeure must notify in writing with 24 hours after becoming aware of the occurrence. The parties will then, within 7 business days examine, unless the force majeure prevents it, if and how the contractual obligations will be met.

Article 11: Privacy statement

All information exchanged by the Parties will be treated with the utmost confidentiality.

All information requested by World Archery and the Organising Committee from the Member Association are necessary to process the event registration and can therefore be communicated only to the contractual partners of World Archery and the Local Organising Committee.

World Archery and the Local Organising committee are authorized to send informative and promotional e-mails to the Member Association, using the WAREOS e-mail address and the contact person provided by the Member Association during the registration.
